- b) all shares of the Company, i.e. 9,861,865 (nine million, eight hundred and sixty-one thousand eight hundred and sixty-five) shares, are covered by the dividend;
- c) 7 July 2025 has been set as the dividend date;
- d) 21 July 2025 has been set as the dividend payment date.
